

## REDWOOD COUNTY, MINNESOTA

DECEMBER 29, 2009

The Board of County Commissioners met in regular session at 8:30 a.m. in the Commissioners' Room in the Government Center, Redwood Falls, Minnesota.

Present for all or portions of the meeting were Commissioners Gary Dahms, Lon Walling, Al Kokesch, John Schueller, and Priscilla Klabunde; Administrator Vicki Knobloch; Highway Engineer Ernie Fiala; Auditor-Treasurer Jean Price; Technology Support Specialist Vicky Firlle and Recorder Joyce Anderson.

Chair Kokesch called the meeting to order asking for the Pledge of Allegiance to the Flag.

On motion by Walling, second by Dahms, the Board voted unanimously to approve the revised agenda.

### CONSENT AGENDA

- On motion by Schueller, second by Dahms, the Board voted unanimously to approve the following:

  - Payment of PHS bills in the amount of \$12,682.98.

### 2008 REDWOOD COUNTY AUDIT

- Price and Knobloch informed the Board of the management exit meeting for the 2008 Redwood County Audit that was conducted on Wednesday, December 16, 2009. On motion by Dahms, second by Schueller, the Board voted unanimously to authorize Board Chair's signature on the Office of the State Auditor Engagement Letter, pursuant to MN Statute §6.48 for Redwood County for the year ending December 31, 2008.
- The Board directed Knobloch and Price to perform random audits of cash transactions of all departments for internal control compliance recommendation made by State Auditors.

### ADMINISTRATOR

- Knobloch presented the 2009 severance paid out by funds. On motion by Walling, second by Schueller, the Board voted unanimously to approve the 2009 severance payouts, as follows:

- Anderson updated the Board on necessary upgrades desired in the Recorder's Office. On motion by Walling, second by Dahms, the Board voted unanimously to approve the purchase of a Fujitsu fi-6770 Document Scanner from Mid America Business Systems at a total cost of \$8,055.00, which includes a yearly maintenance contract, installation and training, to be paid by the Recorder's Equipment Fund.
