Redwood County is making available a fast, convenient, hassle-free way to pay your property taxes with the Direct Payment Plan.

With this convenient program, you can have your property tax payment automatically deducted from your checking or savings account at your financial institution on a semi-annual basis.

The Direct Payment Plan will help you:

- ✓ Save time writing and mailing checks
- ✓ Save money in postage and bank fees
- ✓ Eliminate the worry of late payments or lost checks associated with penalties
- ✓ Be assured your tax payment is always made on time

How does the Direct Payment Plan work?

You authorize payments to be made from your checking or savings account according to the following schedule:

May 15th½ of the annual tax payment
October 15th (non ag parcels)½ of the annual tax payment
November 15th (ag parcels)½ of the annual tax payment

Proof of payment will appear on your bank statement. The authority you give Redwood County to charge your account will remain in effect until **YOU** notify us in **writing** to terminate the authorization. **ANY ADDITION OR DELETION OF PARCELS (DUE TO A SALE OR PURCHASE) OR CHANGE IN ACCOUNT INFORMATION MUST BE SENT TO OUR OFFICE ON A CHANGE FORM.**

You will receive your tax statement yearly, but NO other notice will be sent notifying you of the amount that will be deducted from your account on a semi-annual basis. This will be YOUR RESPONSIBILITY to make sure the funds are in the account that is being debited. If funds are not available on the day the taxes are due, a penalty will be incurred the following day based on the schedule on the back of the tax statement.

Take advantage of this service by completing the attached authorization form and return it to us by the following dates;

April 15thfor First ½ taxes payable May 15th
September 15thfor Second ½ taxes payable October or November 15th
